Resources for Special Needs kids-IEP's, 504's and AB490 Dian Schneider of H.E.A.R.T.S. Connection presented valuable resources to CKC members. Dian's style is a little different because she herself suffers from severe ADHD. It is most helpful for us to hear from an adult who understands where our kids are coming from.

Sometimes our kids cannot voice the things that go on in their heads; either because they do not know or can't articulate what they are experiencing. Our children have unique strengths and needs. Prevention Resource and Referral Services (PRRS) is a statewide, no cost service to parents and caregivers with children (birth to 3 years of age) who may be at risk for developmental delays.

We as parents know that most times needs are not recognized until later and can affect school attendance. AB 490 ensures educational rights and stability for foster youth. A CA Foster Youth Education Task Force booklet is on file for Frequently asked Questions & Answers for your use. We were also given pamphlets that list local resources and the services provided. Thank you H.E.A.R.T.S. Connection and Dian for helping us with our special needs and children with disabilities.
