#### FOSTER CARE OMBUDSMAN UPDATE

The Foster Care Ombudsman's role is to listen to your concerns, to document your complaints and suggestions, to remain neutral and objective and to keep information confidential.

Dear Caregivers,

On behalf of the Department, I would like to say HAPPY NEW YEAR and THANK YOU for your dedication to the children of Kern County. By providing a home to one or more children you are making a difference in the life of a child. Your commitment to providing quality care for our most vulnerable children also supports our efforts in protecting and nurturing abused and neglected children.

Reflecting back on 2014, Over 600 new resource foster families were licensed or approved to care for our foster children. Bakersfield College in partnership with DHS provided over 487 hours of training to prospective and current caregivers. The annual Resource Family Appreciation and Training Dinner in May, was attended by 153 caregivers, staff, and partners. Earlier this month, 254 children and caregivers attended the annual Breakfast with Santa event at the East Hills Mall, and another 164 children and families participated in a similar event in Ridgecrest. The Holiday Cottage along with the community and partners granted over 800 wishes for our foster youth by making youngster's wishes a reality for the holidays.

Lastly, numerous caregivers joined the Caregivers of Kern County (CKC) who provide mentoring, training opportunities and many family activities throughout the year; a copy of the CKC December Newsletter is attached.

As we plan ahead for 2015, we will begin to implement your suggestions for improved support and service delivery; we will provide "pass along" cards and provide incentives to resource families for new referrals made (see details in article). We are creating a mentoring program for new/seasoned caregivers and we are proposing to increase opportunities for resource families and social workers to receive training together on common topics.

We will continue to support you by providing information on the changing laws and regulations affecting foster care and by offering training opportunities to improve your knowledge and skills related to the special needs of our children.

#### ANNOUNCEMENTS FOR ALL CAREGIVERS

- Health and Education Passports (HEP) All children in foster care have rights to medical, dental care, mental health services and appropriate educational services. Please make sure to take with you the child's HEP to All such appointments. This includes school education assessments and mental health treatment. Ensure the doctor is aware of the child's medical/mental health history AND ensure YOU receive updates, treatment plans and information to better care for the foster child in your care. DON'T FORGET to share All updates with child's placement SW.
- Moving? Or Recently Moved?: A quick reminder: if you are going to be moving you need to notify your child's placement social worker and Licensing Program Analyst (LPA) as soon as possible in order to maintain foster care payments. NOTE: Delays in obtaining a new home inspection means possible delays in reimbursement??.
- The Bakersfield College Foster & Kinship Care Education (BC F&KCE) Course Descriptions have been updated and are included with this Newsletter. Please take advantage of the training opportunities which are specifically tailored for ALL our resource (foster) caregivers. The remaining course schedule for 2014-15 is also attached; this includes the Caring for Severe Behavioral/Emotional Needs courses.

#### **NEW FOR 2015:**

- CKC President Alice Esqueda takes leadership. See announcement in CKC Newsletter attached.
- "Pass Along" Cards: Created in a card deck style, these cards will be provided to caregivers interested in helping the Department recruit new licensed resource families. The cards will have basic information on Orientation schedule and Recruitment Line phone number. A space is provided for resource person's name/signature, which can also be used to begin mentorship connection.
- Recruitment Incentives: Beginning with January applications, current resource family caregivers may receive \$50 incentive for each qualifying referral submitted that results in an approved foster care license. New applicants must provide evidence of referral by showing the Pass Along card to Licensing Program Analyst upon application submission.
- Welcome and Meet N Greet Events: Additional events will be planned to welcome and introduce new resource families to seasoned resource families and to DHS staff.

#### **NEW PROGRAM UPDATE:**

The Early Intervention Services (EIS) Program began mid-August 2014. The EIS staff has been conducting developmental screenings using the Ages & Stages Questionnaire, Third Edition in the homes of caregivers. The caregivers have been cooperative in making themselves and the children available and assisting in the completion of the screening tool. Thank you!

As a reminder to caregivers, the EIS staff will mail you an outcome letter advising if the child is on target developmentally, needs to be monitored and re-screened in two months, or whether the child presented concerns and a referral was made to Kern Regional Center for an assessment for Early Start Services. A Kern Regional Center Service Coordinator will either call or send you a letter asking you to contact them to schedule an assessment. Please call to schedule as soon as you receive the call/letter, as KRC has 45 days to process each referral. If the child is no longer in your home, please call KRC to let them know.

#### RESPITE CARE HOMES NEEDED

Are you a licensed foster parent interested in providing "respite care" for other licensed foster parents?

Per Title 22 Regulation 89378 (C) "Respite Care" is temporary care for periods not to exceed 72 hours and shall provided by a licensed, approved or certified caregivers. These services shall not be provided for the purpose of routine, ongoing childcare.

To provide Respite Care, you must:

- Have openings, within your licensed capacity. For example, if you have a licensed capacity for 4 "children" and you have one "child" currently placed in your home, you could accept up to 3 "children" for respite care.
- Have current, age appropriate CPR/First Aid certification and have completed our annual training requirement.
- Get permission from the "child's" Social Worker.
- Get paperwork from the "child's" Social Worker.
- Have an understanding of how to obtain medical care for the "child" while in your care.

County Licensed Foster Family Homes may not use Foster Family Agency Homes for Respite Care.

Dual Licensed Homes (Day Care and Foster Family) may not accept Special Health Care Needs "children" for respite care.

### Bakersfield College Foster & Kinship Care Educational Program Course Descriptions 2014-2015

Tuesday evening courses are offered to foster parents to fulfill the Kern County Department of Human Services mandated eight hour training. Relative/kinship caregivers and non-relative extended family members are encouraged to attend these trainings. Tuesday trainings are held at the Weill Institute, 2100 Chester Ave., Bakersfield, CA 93301. Below please find the course descriptions for the 2014/2015 school year (In alphabetical order by class title). The training schedule is available at www2.bakersfieldcollege.edu/cdt/ (click on Foster and Kinship Care Program)

#### Adoptions & Developmental Impact:

This class will discuss how to guide a child through loss and gain relationships, how to use specific language concerning the process of adoption with a child, how to distinguish the difference between trauma, separation, and attachments children show and how to identify attachment issues/problems concerning child abuse.

#### Allegations-What To Do When an Investigator Knocks:

The participants will focus on the following:

- 1) Title 22 regulations regarding complaint investigation
- 2) How to deal with a complaint investigator, report unusual incidents, and handle a "non-compliance conference"
- 3) How to address and protect oneself and family against allegations.

#### Best Practices for LGBTQ Youth in Care (AB458 & AB1856):

Participants receive information and training on Lesbian, Gay, Bisexual, Transgender and Questioning (LGBTQ) laws and issues related to children placed in foster care and cultural awareness necessary in order to provide a safe and nurturing foster placement for LGBTQ youth.

#### Bonding & Attachment-Fostering Relationships Between Biological/Foster Parents:

The class will review the importance of attachment.

#### Caring for Children with Severe Emotional/Behavioral Needs:

The training explores the causes of emotional and behavioral issues in foster children; tools to address emotional/behavioral issues as a family; and how to identify formal and informal supports in the community for further assistance. The class also addresses changes to DHS policy regarding available funding sources for foster parents caring for children with severe behavior needs.

#### CASA:

This training will review what a CASA (Court Appointed Special Advocate) is, what it means when a CASA is appointed to a child and how to get a CASA assigned to a foster child.

#### Child Abuse Laws & Reporting-What, When, & How to Report It:

The participants will focus on the following:

- 1) Learn definitions of abuse and neglect
- 2) Recognize the signs & symptoms
- 3) Learn how to complete a Suspected Child Abuse Report

#### Child Visitations, Expectations & Guidelines:

The participants will focus on the following:

- 1) The importance of child visitations
- 2) Child visitation guidelines, and
- 3) What to expect.

#### Commercial Sexual Exploitation of Children:

The participants will focus on the following:

- 1. Local Realities -Pimping -Recruiting -Survivor sex perceptions -Labor and Laws
- 2. Goals of Kern County Coalition -Prevention -Protection -Prosecution -Partnership
- 3. Role of Foster Parent: -Keep youth safe -Red Flag and Indicators -Terminology

#### Communicable Diseases (Including Headlice):

The participants will focus on the following: 1) How to properly identify a contagious infection like MRSA staph infection and head lice infestation, 2) How to begin home treatment for the child while protecting the others in the household from contracting the same condition, and 3) When to take a child to a medical provider for treatment

#### Cultural Sensitivity:

This class is designed to provide information about the importance of honoring diversity and how to manage issues in a diverse community and being sensitive to needs of children in foster care.

#### Dream Center Services & Support for ILP/AB12 Youth:

Participants will receive information about available resources to foster youth at the *Dream Center* as well as resources available through the supplemental Independent Living Program (ILP).

#### <u>Drug Babies & Fetal Alcohol Syndrome:</u>

The participants will focus on the following: Fetal Alcohol Syndrome 1) to identify signs and symptoms of Pos Tox babies and how to properly handle each infant. 2) To identify signs and symptoms of Fetal Alcohol Syndrome 3) how to follow up with developmental/health issues. Drug Babies 1) How to understand the prevalence and risks of drug use in pregnancy

#### Grief & Loss Relationships Between Biological/Foster Parents:

Participants will be introduced to the different signs of grief in children depending on their age and understanding the importance of allowing children to grieve. Participants will learn techniques to help without hindering by finding activities to work through it and not stumble into depression. Resources will be provided such as website and book titles for young children and adolescents.

#### Hair & Skin Care of African American Children:

This training will review the three differences in African American skin and identify dry skin on African American children. The training will also review two products that can aid in maintaining healthy hair and skin for African American children.

#### Infant/Toddler Development, Discipline & Safety Milestones:

The participants will focus on the following: 1) Positive discipline (how to make it work for you); 2) Infant/Toddler stages and development; and 3) How to set up a healthy and safe environment.

#### Making It Work –Foster Parents Working Together:

The Participants will focus on the following:

- 1) The priority given to reunifying children with parents,
- 2) The importance of working with birth parents to help reunification succeed,
- 3) How to continue contact with children once they return home,
- 4) How the referral process works for Kern County Mental Health and what services are available for resource families and foster children in their care.

#### Parenting Traumatized Children:

The participants will focus on the following:

- 1) Understanding values of emotional behavior concerns; 2) Understand and develop awareness of triggers; and
- 3) Develop skills to assist traumatized children to recover from trauma

#### Pregnancy & Prenatal Care & Resources:

The participants will focus on the following: 1) The importance of medical supervision; 2) What to expect; and 3) planning for baby.

#### Prudent Parenting, Respite Care & SCIAP Support for Resource Families:

This class will go over the basics of respite care. It define alternative care, short term care and respite care. This class will also go into detail about SCIAP (Specialized Care & Incentive Program). It will discuss what SCIAP as well as how program funds can help cover unexpected/non-recurring expenses associated with care of foster child.

#### Shaken Baby Syndrome & SIDS:

The participants will focus on the following: 1) Ways to decrease the rise of SIDS; 2) Ways to prevent suffocations (accidental); 3) Effects of shaken baby; and 4) Ways to prevent shaken baby syndrome.

#### Special Medical Needs Part 1/2:

The participants focus on the following: 1) To describe at least one disorder in each of the following areas of function: thinking and communicating, breathing, eating, moving, and eliminating; 2) To describe some of the most common treatments and medications for disorders in each of those areas; 3) To name the medical specialists that practice in each area; 4) To discuss the importance of written records when caring for medically fragile children and give

#### Teen Parents Rights & Fostering Connections Success (\*SB500 Applicable):

This class will focus on teen parent rights, the kind of stress teens experience by being pregnant or becoming a parent and what services are available to parenting teens throughout the county.

#### The Court & Your Child (AB490 Ed Liason/AB2096):

The participant will learn about educational rights and services for children in foster care including:

- 1) IEP's (Individual Educational Plans) what is covered and your rights.
- 2) 504's the law.
- 3) AB490 information regarding the recent assembly bill.

#### Training the Trainer (Foster Parent & Kinship Caregiver Facilitator Training):

The participants will focus on the following: 1) How to set up the training environment; 2) How to organize their material and share their experience with foster parents and kinship caregivers; and 3) How to present to topic.

#### Type 1 Diabetes:

This training will go over Type 1 Diabetes. It will cover what to when you receive a diagnosis, monitoring diabetes and living with Diabetes.

#### What's New About Title 22:

This training will review the Title 22 updates by the Kern County Department of Human Services Licensing Staff.

#### Working Successfully with Teen Parents:

The participants will focus on the following: 1) Prenatal care, child development stages, family support services, parenting and life skills education; 2) Community resources for teen parents; who can access them and how; and 3.) Father involvement and child care.

## TO DO RESPITE CARE:

- 1. Have a current opening in your capacity for the number of children that you will be doing respite for
- 2. Get permission from child's Social Worker.
- 3. Get the paperwork from child's Social Worker.
- 4. Have an understanding of how to get medical care for children while in your care.

#### **Respite Care Policy:**

Respite care is the temporary care of a foster child by someone other than the foster parent.

- Caregiver is subject to Social Worker approval.
- Limited to 7 days/168 hours per child or 12 days/288 hours for a child receiving a SCI rate of Level 2 or higher.
- DHS' fiscal year is July 1st to June 30th. Respite Care hours must be used during the fiscal year. All unused days for current year **cannot** be carried over to next year.




